## The latest news as of 6pm on Friday 13 November

7 deaths and 482 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 7 additional deaths among people with COVID-19 in Ireland. Of the deaths reported today, all occurred in November
- there have been 1,972 COVID-19 related deaths in Ireland
- 482 additional cases of COVID-19 have been confirmed
- there have now been 67,099 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 258 COVID-19 patients are hospitalised, of which 35 are in ICU. There have been 12 additional hospitalisations in the past 24 hours
