The latest news as of 6pm on Saturday 14 November

6 deaths and 456 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland. Of the deaths reported today, all occurred in November
- there have been 1,978 COVID-19 related deaths in Ireland
- 456 additional cases of COVID-19 have been confirmed
- there have now been 67,526 confirmed cases of COVID-19 in Ireland
- as of 2pm today, 254 COVID-19 patients are hospitalised, of which 32 are in ICU. 11 additional hospitalisations in the past 24 hours.
