The latest news as of 5.45pm on Monday 16 November

5 deaths and 456 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland. All deaths reported today occurred in November
- there have been 1,984 COVID-19 related deaths in Ireland
- 456 additional cases of COVID-19 have been confirmed
- there have now been 68,356 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 274 COVID-19 patients are hospitalised, of which 33 are in ICU. There have been 10 additional hospitalisations in the past 24 hours
