The latest news as of 6.30pm on Tuesday 17 November

11 deaths and 366 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 11 additional deaths among people with COVID-19 in Ireland. All deaths reported today occurred in November
- there have been 1,995 COVID-19 related deaths in Ireland
- 366 additional cases of COVID-19 have been confirmed
- there have now been 68,686 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 272 COVID-19 patients are hospitalised, of which 34 are in ICU. There have been 14 additional hospitalisations in the past 24 hours
