The latest news as of 6pm on Wednesday 18 November

12 deaths and 379 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 12 additional deaths among people with COVID-19 in Ireland
- there have been 2,006 COVID-19 related deaths in Ireland
- 379 additional cases of COVID-19 have been confirmed
- there have now been 69,058 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 282 COVID-19 patients are hospitalised, of which 33 are in ICU. There have been 22 additional hospitalisations in the past 24 hours
