The latest news as of 6pm on Thursday 19 November

4 deaths and 429 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 4 additional deaths among people with COVID-19 in Ireland
- there have been 2,010 COVID-19 related deaths in Ireland
- 429 additional cases of COVID-19 have been confirmed
- there have now been 69,473 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Thursday), 290 COVID-19 patients are hospitalised, of which 33 are in ICU. There have been 15 additional hospitalisations in the past 24 hours
