The latest news as of 5.30pm on Friday 20 November

8 deaths and 330 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 8 additional deaths among people with COVID-19 in Ireland
- there have been 2,018 COVID-19 related deaths in Ireland
- 330 additional cases of COVID-19 have been confirmed
- there have now been 69,802 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 283 COVID-19 patients are hospitalised, of which 33 are in ICU. There have been 13 additional hospitalisations in the past 24 hours
