## The latest news as of 5.30pm on Saturday 21 November

4 deaths and 344 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 4 additional deaths among people with COVID-19 in Ireland
- there have been 2,022 COVID-19 related deaths in Ireland
- 344 additional cases of COVID-19 have been confirmed
- there have now been 70,143 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Saturday), 269 COVID-19 patients are hospitalised, of which 32 are in ICU. There have been 12 additional hospitalisations in the past 24 hours
