The latest news as of 6pm on Monday 23 November

252 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 2,022 COVID-19 related deaths in Ireland
- 252 additional cases of COVID-19 have been confirmed
- there have now been 70,711 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 289 COVID-19 patients are hospitalised, of which 33 are in ICU. There have been 11 additional hospitalisations in the past 24 hours
