## The latest news as of 5.45pm on Tuesday 24 November

6 deaths and 226 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland
- there have been 2,028 COVID-19 related deaths in Ireland
- 226 additional cases of COVID-19 have been confirmed
- there have now been 70,930 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 292 COVID-19 patients are hospitalised, of which 36 are in ICU. There have been 18 additional hospitalisations in the past 24 hours
