The latest news as of 6.15pm on Wednesday 25 November

6 deaths and 269 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland
- there have been 2,033 COVID-19 related deaths in Ireland
- 269 additional cases of COVID-19 have been confirmed
- there have now been 71,187 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 260 COVID-19 patients are hospitalised, of which 36 are in ICU. There have been 23 additional hospitalisations in the past 24 hours
