## The latest news as of 6pm on Thursday 26 November

3 deaths and 335 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 2,036 COVID-19 related deaths in Ireland
- 335 additional cases of COVID-19 have been confirmed
- there have now been 71,494 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Thursday), 246 COVID-19 patients are hospitalised, of which 35 are in ICU. There have been 15 additional hospitalisations in the past 24 hours
