The latest news as of 5.45pm on Friday 27 November

7 deaths and 206 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 7 additional deaths among people with COVID-19 in Ireland
- there have been 2,043 COVID-19 related deaths in Ireland
- 206 additional cases of COVID-19 have been confirmed
- there have now been 71,699 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 248 COVID-19 patients are hospitalised, of which 35 are in ICU. There have been 10 additional hospitalisations in the past 24 hours
