The latest news as of 5.30pm on Saturday 28 November

7 deaths and 243 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 7 additional deaths among people with COVID-19 in Ireland
- there have been 2,050 COVID-19 related deaths in Ireland
- 243 additional cases of COVID-19 have been confirmed
- there have now been 71,942 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Saturday), 254 COVID-19 patients are hospitalised, of which 31 are in ICU. There have been 20 additional hospitalisations in the past 24 hours
