The latest news as of 5.30pm on Sunday 29 November

2 deaths and 299 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 2 additional deaths among people with COVID-19 in Ireland
- there have been 2,052 COVID-19 related deaths in Ireland
- 299 additional cases of COVID-19 have been confirmed
- there have now been 72,241 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Sunday), 257 COVID-19 patients are hospitalised, of which 30 are in ICU. There have been 7 additional hospitalisations in the past 24 hours
