## The latest news as of 5.45pm on Wednesday 1 December

5 deaths and 270 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland
- there have been 2,074 COVID-19 related deaths in Ireland
- 270 additional cases of COVID-19 have been confirmed
- there have now been 73,066 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 231 COVID-19 patients are hospitalised, of which 31 are in ICU. There have been 27 additional hospitalisations in the past 24 hours
