The latest news as of 6pm on Thursday 3 December

6 deaths and 183 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland
- there have been 2,080 COVID-19 related deaths in Ireland
- 183 additional cases of COVID-19 have been confirmed
- there have now been 73,228 confirmed cases of COVID-19 in Ireland
- as of 2pm today, 239 COVID-19 patients are hospitalised, of which 32 are in ICU. 10 additional hospitalisations in the past 24 hours.
