## The latest news as of 6pm on Friday 4 December

6 deaths and 265 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland
- there have been 2,086 COVID-19 related deaths in Ireland
- 265 additional cases of COVID-19 have been confirmed
- there have now been 73,491 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 232 COVID-19 patients are hospitalised, of which 27 are in ICU. There have been 14 additional hospitalisations in the past 24 hours
