The latest news as of 5.30pm on Saturday 5 December

13 deaths and 456 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 13 additional deaths among people with COVID-19 in Ireland
- there have been 2,099 COVID-19 related deaths in Ireland
- 456 additional cases of COVID-19 have been confirmed
- there have now been 73,948 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Saturday), 231 COVID-19 patients are hospitalised, of which 28 are in ICU. There have been 5 additional hospitalisations in the past 24 hours
