## The latest news as of 5.30pm on Sunday 6 December

301 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 2,099 COVID-19 related deaths in Ireland
- 301 additional cases of COVID-19 have been confirmed
- there have now been 74,246 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Sunday), 231 COVID-19 patients are hospitalised, of which 28 are in ICU. There have been 8 additional hospitalisations in the past 24 hours
