The latest news as of 5.45pm on Tuesday 8 December

1 death and 215 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have been 2,097 COVID-19 related deaths in Ireland
- 215 additional cases of COVID-19 have been confirmed
- there have now been 74,682 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 210 COVID-19 patients are hospitalised, of which 31 are in ICU. There have been 8 additional hospitalisations in the past 24 hours
