The latest news as of 5.45pm on Wednesday 9 December

5 deaths and 227 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland
- there have been 2,102 COVID-19 related deaths in Ireland
- 227 additional cases of COVID-19 have been confirmed
- there have now been 74,900 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 224 COVID-19 patients are hospitalised, of which 38 are in ICU. There have been 14 additional hospitalisations in the past 24 hours
