## The latest news as of 5.45pm on Friday 11 December

3 deaths and 313 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 2,120 COVID-19 related deaths in Ireland
- 313 additional cases of COVID-19 have been confirmed
- there have now been 75,507 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 197 COVID-19 patients are hospitalised, of which 35 are in ICU. There have been 12 additional hospitalisations in the past 24 hours
