# The latest news as of 5.30pm on Saturday 11 December

3 deaths and 248 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 2,123 COVID-19 related deaths in Ireland
- 248 additional cases of COVID-19 have been confirmed
- there have now been 75,756 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Saturday), 185 COVID-19 patients are in hospital, of which 31 are in ICU. There have been 10 additional hospitalisations in the past 24 hours
