The latest news as of 5.15pm on Sunday 13 December

1 death and 429 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have been 2,124 COVID-19 related deaths in Ireland
- 429 additional cases of COVID-19 have been confirmed
- there have now been 76,185 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Sunday), 193 COVID-19 patients are hospitalised, of which 31 are in ICU. There have been 13 additional hospitalisations in the past 24 hours
