The latest news as of 5.45pm on Monday 14 December

2 deaths and 264 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 2 additional deaths among people with COVID-19 in Ireland
- there have been 2,126 COVID-19 related deaths in Ireland
- 264 additional cases of COVID-19 have been confirmed
- there have now been 76,449 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 215 COVID-19 patients are hospitalised, of which 33 are in ICU. There have been 17 additional hospitalisations in the past 24 hours
