The latest news as of 5.45pm on Tuesday 15 December

8 deaths and 329 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 8 additional deaths among people with COVID-19 in Ireland
- there have been 2,134 COVID-19 related deaths in Ireland
- 329 additional cases of COVID-19 have been confirmed
- there have now been 76,776 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 196 COVID-19 patients are hospitalised, of which 31 are in ICU. There have been 13 additional hospitalisations in the past 24 hours
