The latest news as of 6pm on Wednesday 15 December

6 deaths and 431 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland
- there have been 2,140 COVID-19 related deaths in Ireland
- 431 additional cases of COVID-19 have been confirmed
- there have now been 77,197 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 207 COVID-19 patients are hospitalised, of which 30 are in ICU. There have been 22 additional hospitalisations in the past 24 hours
