## The latest news as of 7.15pm on Thursday 17 December

3 deaths and 484 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 3 additional deaths among people with COVID-19 in Ireland
- there have been 2,143 COVID-19 related deaths in Ireland
- 484 additional cases of COVID-19 have been confirmed
- there have now been 77,678 confirmed cases of COVID-19 in Ireland
- a f 2pm today 200 COVID-19 patients are hospitalised, of which 31 are in ICU. 30 additional hospitalisations in the past 24 hours.
