## The latest news as of 5.45pm on Friday 18 December

6 deaths and 582 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland
- there have been 2,149 COVID-19 related deaths in Ireland
- 582 additional cases of COVID-19 have been confirmed
- there have now been 78,254 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 198 COVID-19 patients are hospitalised, of which 34 are in ICU. There have been 13 additional hospitalisations in the past 24 hours
