The latest news as of 5.30pm on Saturday 19 December

5 deaths and 527 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 5 additional deaths among people with COVID-19 in Ireland
- there have been 2,154 COVID-19 related deaths in Ireland
- 527 additional cases of COVID-19 have been confirmed
- there have now been 78,776 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Saturday), 207 COVID-19 patients are hospitalised, of which 28 are in ICU. There have been 12 additional hospitalisations in the past 24 hours
