### The latest news as of 5.45pm on Monday 21 December

764 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 2.158 COVID-19 related deaths in Ireland
- 727 additional cases of COVID-19 have been confirmed
- there have now been 80,267 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 241 COVID-19 patients are hospitalised, of which 29 are in ICU. There have been 18 additional hospitalisations in the past 24 hours
