## The latest news as of 6pm on Tuesday 22 December

13 deaths and 970 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 13 additional deaths among people with COVID-19 in Ireland
- there have been 2,171 COVID-19 related deaths in Ireland
- 970 additional cases of COVID-19 have been confirmed
- there have now been 81,228 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 238 COVID-19 patients are hospitalised, of which 28 are in ICU. There have been 23 additional hospitalisations in the past 24 hours
