The latest news as of 6pm on Wednesday 23 December

13 deaths and 938 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 13 additional deaths among people with COVID-19 in Ireland. Of the 13 deaths, 10 occurred in December
- there have been 2,184 COVID-19 related deaths in Ireland
- 938 additional cases of COVID-19 have been confirmed
- there have now been 82,155 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 251 COVID-19 patients are hospitalised, of which 25 are in ICU. There have been 24 additional hospitalisations in the past 24 hours
