The latest news as of 3,30pm on Friday 25 December

2 deaths and 1,025 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 2 additional deaths among people with COVID-19 in Ireland in the last 24 hours
- there have been 2,194 COVID-19 related deaths in Ireland
- 1,025 additional cases of COVID-19 have been confirmed in the last 24 hours
- there have now been 84,098 confirmed cases of COVID-19 in Ireland
