## The latest news as of 4pm on Saturday 26 December

6 deaths and 1,296 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland in the last 24 hours
- there have been 2,200 COVID-19 related deaths in Ireland
- 1,296 additional cases of COVID-19 have been confirmed in the last 24 hours
- there have now been 85,394 confirmed cases of COVID-19 in Ireland
