The latest news as of 5.45pm on Monday 28 December

1 death and 765 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 1 additional death among people with COVID-19 in Ireland
- there have been 2.205 COVID-19 related deaths in Ireland
- 765 additional cases of COVID-19 have been confirmed in the last 24 hours
- there have now been 86,894 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 359 COVID-19 patients are hospitalised, of which 30 are in ICU. There have been 41 additional hospitalisations in the past 24 hours, with 5 additional admissions to ICU
