The latest news as of 6.15pm on Tuesday 29 December

9 deaths and 1,546 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 9 additional deaths among people with COVID-19 in Ireland
- there have been 2,213 COVID-19 related deaths in Ireland
- 1,546 additional cases of COVID-19 have been confirmed in the last 24 hours
- there have now been 88,439 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 411 COVID-19 patients are hospitalised, of which 34 are in ICU. There have been 47 additional hospitalisations in the past 24 hours
