The latest news as of 5.30pm on Wednesday 30 December

13 deaths and 1,718 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 13 additional deaths among people with COVID-19 in Ireland
- there have been 2,226 COVID-19 related deaths in Ireland
- 1,718 additional cases of COVID-19 have been confirmed in the last 24 hours
- there have now been 90,157 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 455 COVID-19 patients are hospitalised, of which 37 are in ICU. There have been 60 additional hospitalisations in the past 24 hours
