The latest news as of 4.20pm on Thursday 31 December

12 deaths and 1,620 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 12 additional deaths among people with COVID-19 in Ireland
- there have been 2,237 COVID-19 related deaths in Ireland
- 1,620 additional cases of COVID-19 have been confirmed in the last 24 hours
- there have now been 91,779 confirmed cases of COVID-19 in Ireland
- As of 2pm today (Thursday), 490 COVID-19 patients are hospitalised, of which 42 are in ICU. There have been 58 additional hospitalisations in the past 24 hours
