# The latest news as of 6.45pm on Friday 1 January

11 deaths and 1.754 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 11 additional deaths among people with COVID-19 in Ireland
- there have been 2,248 COVID-19 related deaths in Ireland
- 1,754 additional cases of COVID-19 have been confirmed in the last 24 hours
- there have now been 93,552 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 504 COVID-19 patients are hospitalised, of which 47 are in ICU. There have been 46 additional hospitalisations in the past 24 hours
