The latest news as of 6.10pm on Saturday 2 January

4 deaths and 3,394 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 4 additional deaths among people with COVID-19 in Ireland
- there have been 2,252 COVID-19 related deaths in Ireland
- 3,394 additional cases of COVID-19 have been confirmed in the last 24 hours
- there have now been 96,926 confirmed cases of COVID-19 in Ireland
- as of 2pm today, 607 COVID-19 patients are hospitalised, of which 56 are in ICU. There have been 71 additional hospitalisations in the past 24 hours.
