The latest news as of 5.45pm on Sunday 3 January

7 deaths and 4,962 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 7 additional deaths among people with COVID-19 in Ireland
- there have been 2,259 COVID-19 related deaths in Ireland
- 4,962 additional cases of COVID-19 have been confirmed
- there have now been 101,887 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Sunday), 685 COVID-19 patients are hospitalised, of which 62 are in ICU. There have been 96 additional hospitalisations in the past 24 hours
