## The latest news as of 6.20pm on Monday 4 January

6 deaths and 6,110 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 6 additional deaths among people with COVID-19 in Ireland
- there have been 2,265 COVID-19 related deaths in Ireland
- 6,110 additional cases of COVID-19 have been confirmed
- there have now been 107,997 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 776 COVID-19 patients are hospitalised, of which 70 are in ICU. There have been 92 additional hospitalisations in the past 24 hours
