The latest news as of 6pm on Tuesday 5 January

17 deaths and 5.325 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 17 additional deaths among people with COVID-19 in Ireland. 16 of today's reported deaths occurred in January
- there have been 2.282 COVID-19 related deaths in Ireland
- 5,325 additional cases of COVID-19 have been confirmed
- there have now been 113,322 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 840 COVID-19 patients are hospitalised, of which 76 are in ICU. There have been 102 additional hospitalisations in the past 24 hours
