The latest news as of 6pm on Wednesday 6 January

17 deaths and 7.836 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 17 additional deaths among people with COVID-19 in Ireland
- there have been 2,299 COVID-19 related deaths in Ireland
- 7,836 additional cases of COVID-19 have been confirmed
- there have now been 121,154 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 954 COVID-19 patients are hospitalised, of which 88 are in ICU. There have been 105 additional hospitalisations in the past 24 hours
