The latest news as of 7.15pm on Thursday 7 January

10 deaths and 6,521 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 10 additional deaths among people with COVID-19 in Ireland
- there have been 2,307 COVID-19 related deaths in Ireland
- 6,521 additional cases of COVID-19 have been confirmed
- there have now been 127,657 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Thursday), 1,043 COVID-19 patients are hospitalised, of which 96 are in ICU. There have been 99 additional hospitalisations in the past 24 hours
