The latest news as of 6.30pm on Friday 8 January

20 deaths and 8.248 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 20 additional deaths among people with COVID-19 in Ireland
- there have been 2,327 COVID-19 related deaths in Ireland
- 8,248 additional cases of COVID-19 have been confirmed
- there have now been 135,884 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 1,180 COVID-19 patients are hospitalised, of which 109 are in ICU. There have been 116 additional hospitalisations in the past 24 hours
