The latest news as of 5.20pm on Saturday 9 January

9 deaths and 4,842 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 8 additional deaths among people with COVID-19 in Ireland
- there have been 2,336 COVID-19 related deaths in Ireland
- 4,842 additional cases of COVID-19 have been confirmed
- there have now been 140,727 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Saturday), 1,293 COVID-19 patients are hospitalised, of which 119 are in ICU. There have been 102 additional hospitalisations in the past 24 hours


