The latest news as of 6pm on Monday 11 January

8 deaths and 4,929 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 8 additional deaths among people with COVID-19 in Ireland
- there have been 2,352 COVID-19 related deaths in Ireland
- 4,929 additional cases of COVID-19 have been confirmed
- there have now been 152,539 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 1,582 COVID-19 patients are hospitalised, of which 146 are in ICU. There have been 156 additional hospitalisations in the past 24 hours
